School-Parent Compact

How does Diegueño Middle School address this?

Provide high-quality curriculum and instruction in supportive and effective learning
environment that enables participating children to meet California's student academic
achievement standards as follows: having highly qualified teachers in the classroom,
providing meaningful staff development and collaboration, consistently developing and
revising curriculum to address the changing state standards and student needs,
providing students with multiple entry points when engaging with curriculum, additional
student support will be available both within and outside the school day, counseling and

social work services will be available for students, and lunch time activities are designed to help build connectedness to Diegueño Middle School and peers as research shows connected students perform better in the classroom.

Diegueño Middle School engages Title 1, Part A parents and family members to improve the achievement of their children in meaningful interactions with Diegueño Middle School. This Compact supports a partnership among staff, parents and family members, and the community to improve student academic achievement. To help achieve these goals, Diegueño Middle School has established the following practices:

- Diegueño Middle School provides Title 1, Part A parents and family members with
 assistance in understanding the state's academic content standards, assessments, and
 how to monitor and improve the achievement of their children (ESSA Section
 1116[e][1]) in the following ways: by providing parents with frequent reports on their
 child's progress through teacher communication, teacher webpages, updated Aeries
 reports, 5-Week D/F notifications, 9 week progress reports, and semester grades.
- Diegueño Middle School provides Title 1, Part A parents and family members with materials and training to help them improve the achievement of their children (ESSA Section 1116[e][2]). Parents are invited to attend PTSA meetings, Parent Workshops, Title 1 meetings, ELAC meetings and Coffee with the Principal. Parents are informed of these opportunities via e-option, emails, and all-call phone calls home.
- With the assistance of Title I, Part A parents and family members, Diegueño Middle School educates staff members in the value of parents and family members contributions, and how to work with parents and family members as equal partners (ESSA Section 1116[e][3]). Diegueño will educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and Diegueño Middle School; (20 U.S.C 6318 (e)(3)). Professional development is provided to staff regarding parents as partners and the importance of parental involvement in student success.
- Diegueño Middle School coordinates and integrates Title 1, Part A parental involvement program with other programs, and conducts other activities, such as resource centers, to encourage and support parents and family members in more fully participating in the education of their children (ESSA Section 1116[e][4]). Parents are encouraged to become active members of the PTSA, volunteer on campus, and attend Parent Workshops throughout the year.

- Diegueño Middle School distributes information related to school and parent programs, meetings, and other activities to Title 1, Part A parents and family members in a format and language that the parents and family members can understand (ESSA Section 1116[e][5]). Diegueño informs parents through e-options, all-calls, emails, mailed letters, and phone calls home from teachers, counselors, intervention coordinator, and administrators.
- Diegueño Middle School will provide support for parent and family member involvement activities requested by Title I, Part A parents and family members (ESSA Section 1116[e][14]) by encouraging to become active members of the PTSA, volunteer on campus, and attend Parent Workshops to help throughout the year. Parents can contact administration or intervention coordinator to request any additional support.

Diegueño Middle School sends out weekly parent email communications to all parents with information about school activities and events including such events as Back to School Night, parent workshops, Title 1 Information Night, ELAC meetings and PTSA meetings. Information is distributed in all the major languages spoken by the families of the students at Diegueño when possible.

Student Responsibilities:

- I will give to my parents or the adult responsible for my welfare, all notices and information received by me from my school every day.
- I will work with my family to establish a homework routine.
- I will communicate with my teachers if I need help with class content.

Parent Responsibilities:

I realize that my child's middle school years are very important, and I understand that my participation in my child's education will help his or her achievement and attitude. Therefore, I agree to carry out the following responsibilities to the best of my ability:

- I will provide a quiet place for my child to study.
- I will encourage my child to complete his/her homework.
- I will make sure my child gets an adequate night's sleep.
- I will see to it that my child arrives at school on time each day.
- I will encourage my child to read every day (30 minutes).
- I will return all school communications promptly.
- I will attend Back to School Night, parent conferences and meetings related to my child.
- I will monitor and limit TV and computer use to ensure my child is completing their school work and going to bed at a reasonable hour to consistently reach eight hours of sleep.
